#### A Message from NACO Executive Director Jon Cannon

To all County Board Chairs, County Clerks, and County Treasurers:

I am very pleased to announce that your Nebraska Association of County Officials, at the direction of the NACO Board, have engaged Lutz & Company – a CPA firm headquartered in Omaha with offices in Lincoln, Grand Island, and Hastings – to provide assistance to counties in the administration of those State and Local Fiscal Recovery Funds as part of the American Rescue Plan Act (ARPA). Lutz will provide consulting services for any county in need of assistance in its use of the ARPA funds. Here are some of the kinds of services they can offer:

- Setting up processes and internal controls for best practices for receipt of funds;
- Consulting and identification of eligible uses of funds;
- Consulting, monitoring, and reporting of eligible programs;
- Compliance, documentation, and reporting of all necessary report filings;
- Assistance with grant/contracts pre-approval processes;
- Assistance with strategic planning;
- Assistance with newly required Single Audits of ARPA funds.

This list is non-exhaustive, so if you aren't sure if the assistance you require would be covered, just ask!

Also, it is important to note that fees paid for these kinds of consulting services are also eligible uses of ARPA funds.

NACO remains available for any questions you may have regarding the administration of ARPA funds; however, we very quickly realized that there were some questions we did not have the expertise to answer. We may refer you on to Lutz if we determine it would be appropriate.

Treasury Releases Walkthrough Of Recovery Fund Reporting Portal Recovery Fund Reports Due August 31

Counties that receive funding from the State and Local Fiscal Recovery Fund are required to meet compliance and reporting responsibilities. On August 31, both the Interim Report and the Recovery Plan Performance Report are due to the U.S. Treasury Department.

The Interim Report must be completed by all counties that have certified for Recovery Funds. Additionally, the Recovery Plan Performance Report must be completed by counties that have a population of 250,000 and above.

The U.S. Treasury released a recorded presentation providing a walkthrough of the reporting portal and instructions on completing required reports.

## Broadband Bridge Act Grant Program Working to Expand Broadband to all Nebraskans

On May 26, 2021, the Governor signed the Nebraska Broadband Bridge Act (the Act), LB 388, which created the Nebraska Broadband Bridge Program (NBBP) to facilitate and fund the deployment of broadband networks in unserved and underserved areas of Nebraska. The NBBP is designed to assist with costly deployment projects that might not otherwise occur without public assistance. The Nebraska Public Service Commission has the authority to grant awards to assist applicants with eligible infrastructure installation costs for qualifying projects. Qualifying projects must provide broadband Internet service scalable to one hundred megabits per second for uploading, or greater (100Mbps/100Mbps). Applicants are required to provide matching funds equal to at least fifty percent of the total development costs of the project.
